DUES RENEWAL: Renewal dues postmarked on or before Sept. 10 are requested.

INITIATION FEE: Initiation fee is to be paid in full with application. Trial Membership fee may be applied toward initiation fee at time of full membership application.

FISCAL YEAR: September 1 – August 31.

SAILING SEASON: Labor Day weekend through Memorial Day weekend (9 months). Informal racing and sailing are held during summer months.

RENEWING MEMBERS DUES: Dues are payable in full at beginning of fiscal year. Members joining over the summer period will have all dues applied to the next fiscal year, but have full use of the facility and all member benefits during the summer period.

NEW MEMBER DUES:

Trial Membership	\$100 for 90 days
Family	\$300 annual or prorated @ \$25.00 /month for balance of the fiscal year
Regular	\$250 annual or prorated @ \$20.83 /month for balance of the fiscal year
Social	\$ 75 annual
Junior	\$ 50 annual

BOAT STORAGE: Sailboat and trailer storage only. Storage fee is due at beginning of fiscal year. New members may prorate storage fee based on the 12 month fiscal year. All sailboat owners desiring to store their boat on Club property must be Trial, Family, Regular or Junior members.

Sailboat on trailer storage fee: \$12.00 per foot per year (boat length) – maximum boat length 20'

Laser, Sunfish, Opti Pram storage fee: \$6.00 per foot per year.

FAMILY MEMBERSHIP: Includes spouse and children up to age 20 on Sept. 1 of current fiscal year.

JUNIOR MEMBERSHIP: Available to anyone under age 20 on Sept. 1 of current fiscal year and is not subject to initiation fee. Upon reaching age 20, a Junior member may upgrade to Regular, Family or Social membership without incurring the initiation fee as long as there is no break in membership continuity.

REGULAR AND FAMILY MEMBERSHIPS: Are entitled to one vote on all matters coming before the Club's general membership. Junior, Social and Trial members have no vote.

TRIAL MEMBERSHIP: Provides full non-voting membership and benefits for a period of 90 days. Boat storage is permitted at applicable fee. 100% of Trial Membership dues may be applied towards initiation fee.

DUTY ASSIGNMENTS: All Duty Assignments are on a volunteer basis only. Safety Boat and Race Committee Boat assistance is always welcome.

PRORATING FEES: The Initiation fee can not be prorated. New members joining in mid-year may prorate membership dues and boat storage fee based on the 12 month fiscal year (Sept. 1 thru Aug. 31).
