



## LESC Member Fee Schedule

**SAILING SEASON:** Labor Day weekend through Memorial Day weekend (9 months). Informal racing and sailing are held during summer months.

**MEMBERSHIP:** New member will submit application as Trial, Full, Associate or Junior and include the appropriate fees (dues, Initiation and boat storage fee) and sales tax. All applications for Trial, Full, Associate and Junior membership will be reviewed by the Board of Directors for continued membership after 90 days.

**TRIAL MEMBERSHIP:** Includes club racing and boat storage privileges and full use of facilities. The Trial Membership provides full non-voting membership and benefits of Full membership for a period of 90 days. Full membership (Full, Associate or Junior memberships) will be considered by the Board of Directors prior to the end of this period. Trial membership is offered once only to prospective members. Boat storage is permitted at applicable fee. 100% of Trial Membership dues may be applied towards initiation fee immediately following trial period.

**FULL MEMBERSHIP:** Includes member, spouse, partners and children up to age 20 on September 1 of current fiscal year. Membership entitles members to club racing and boat storage privileges and full use of facilities. Member is entitled to one vote on all matters coming before the Club's general membership. Junior, Associate and Trial members have no vote.

**ASSOCIATE MEMBERSHIP:** Includes boat launching and full use of facilities but no club racing or boat storage privileges.

**JUNIOR MEMBERSHIP:** Available to anyone under age 20 on September 1 of current fiscal year (also applies to ages 20 to 25 in full time education) and is not subject to initiation fee. Upon reaching age 20, a Junior member may upgrade to Full or Associate membership without incurring the initiation fee as long as there is no break in membership continuity. Please include birth date of Junior member and indicate parent or guardian for sponsor. Sponsor must sign application unless Junior member is 18 years or older.

**INITIATION FEE:** Initiation fee is to be paid in full with acceptance for Full or Associate membership. Trial Membership dues may be applied toward initiation fee at time of full membership acceptance if applied following expiration of trial period.

**DUTY ASSIGNMENTS:** To fulfill its mission, the Club conducts races on alternate weekends for its members and further host seven major regattas. Members are expected to volunteer their time and effort to make these activities happen. Safety Boat and Race Committee Boat assistance is always welcome.

**MEMBERSHIP DUES:** Dues are payable in full at beginning of fiscal year (September 1 thru August 31). Members joining over the summer period will have all dues applied to the next fiscal year, but have full use of the facility and all member benefits during the summer period.

**BOAT STORAGE:** Sailboat and trailer storage only. All sailboat owners desiring to store their boat on Club property must be Trial, Full or Junior members. Storage fee is due at beginning of fiscal year. Fleet boats 15ft or longer (MC, FS, WF) pay \$262.15 per year. Fleet boats under 15ft (Laser, Opti) pay \$144.45 per year. Non fleet boats pay \$304.95 per year. No storage of sailboats over 20ft allowed. New members may prorate storage fee based on the 12 month fiscal year. Trial members wishing to store a boat must pay 3 month storage fee (\$65.54 - boat 15' or longer; \$36.11 – boat under 15'; \$76.24 for non-fleet boats) with Trial Membership Application.

**PRORATING FEES:** The Initiation fee cannot be prorated. After acceptance of trial member for Full or Associate membership, membership dues and boat storage fees are prorated based on the 12 month fiscal year (September 1 thru August 31). Applications processed during the summer period will have all fees applied to the next fiscal year, but new members have full use of the facilities during the summer period.

You further agree that if you fail to promptly remove your Boat and Equipment from the Club's property upon the expiration of that period, and your failure continues for more than thirty days after the Club sends you a letter requiring you to remove your Boat and Equipment, your Boat and Equipment will be deemed abandoned. You agree that such a letter from the Club will be send via First Class US Mail addressed to your address as shown on Club records, with the thirty days measured from the date the letter is deposited with the US Postal Service. If your Boat and Equipment are deemed abandoned, your Boat and Equipment may be retained by the Club as the Club's own property, sold by the Club, or otherwise disposed of by the Club in any manner the Club finds to be appropriate. In no event shall the Club have any duty to secure, maintain, preserve or protect any Boat and Equipment which is deemed abandoned. Should the Club elect to sell a Boat and Equipment deemed abandoned, the Club may do so for any price acceptable to the Club in its sole and absolute discretion, which need not be fair market value, and the Club may receive and retain the proceeds of the sale and apply those proceeds against the Club's charges for the storage of the abandoned Boat and Equipment and any costs arising from the abandonment of the Boat and Equipment and the Club may retain any balance to be used for the purposes of the Club.
